

DECISION

**on the issuance of the Implementation Roadmap
for Vietnam's Sustainable Development Goals until 2030**

THE PRIME MINISTER

in pursuant to the Law on Government Organization dated 19th June 2015;

in pursuant to Resolution 01/NQ-CP dated 01st January 2018 of the Government on key tasks and measures to implement the Socio-Economic Development Plan and the State Budget Estimate 2018;

in consideration of the proposal of Minister of Planning and Investment,

HEREBY DECIDES TO:

Article 1. Issue together with this Decision the Implementation Roadmap for Vietnam's Sustainable Development Goals as determined in the Decision 622/QD-TTg dated 10th May 2017 by the Prime Minister on the National Action Plan for the Implementation of the 2030 Sustainable Development Agenda.

For targets without a proposed roadmap, ministries and agencies in charge should set a plan and concrete programme to implement as required by the National

Action Plan for the Implementation of the 2030 Sustainable Development Agenda as approved by the Prime Minister.

Article 2. This Decision shall take effect from the date of signing.

Article 3. Ministers, Heads of ministerial- level agencies, Head of subordinate bodies of the Government, Chairmen of People's Committees of provinces and centrally-managed cities and other relevant institutions shall be responsible for implementing this Decision./.
